Special Council Meeting Minutes – 01/24/2022 Council Chambers

- I. <u>Call to Order:</u> was called to order by Mayor Gastineau @ 6:00 PM
 - a. Prayer
 - b. Pledge of Allegiance
 - c. City Clerk Ruble was absent and Mayor Gastineau ask Deborah Staley to record the minutes
- II. <u>Roll Call</u>: by Deborah Staley. Council Members Rummel present, Morris present, Harbort present, Hefner absent, McMinn Present, and Shetron Absent. We have a quorum
- III. <u>Confirmation of Public Access via YouTube Live:</u> Mayor Gastineau announced to any one following the meeting on YouTube Live that they can text any comments or questions to 501-743-2501

IV. Special Business:

- a. Resolution R-2022-05: A Resolution authorizing the Mayor or City Clerk to enter into a contract with Davis Playgrounds to construct inclusive playground equipment as a part of the Arkansas State Parks Outdoor Matching Grant Program
 - Mayor ask Deborah Staley to read the title of the Resolution
 - Mayor stated the Resolution had the original bid of \$81,503.76 for the ADA compliant playground, bid for \$3,506.35 for the Gear Panel for the original ADA compliant playground and bid of \$23,794.44 for the wheelchair swing with frame and rubber surface. Mayor also stated that the City will be actively seeking donations to offset the additional cost; otherwise the funds will come from City reserves.
 - Council discussed the pros and cons of making this an all-inclusive playground.
 - Council member Harbort motioned to accept Resolution R-2022-05 with all three components for a total playground cost of \$108,804.55; Council member McMinn seconded.
 - Roll Call vote:

 - 4. Council member McMinn yea
 - 5. Resolution passed with a vote of 4 0.
 - Mayor Gastineau will contact Davis Playgrounds to sign the construction contract.
