A RESOLUTION AUTHORIZING THE PURCHASE AN ALL-TERRAIN VEHICLE (SIDE-BY-SIDE) FOR THE WARD POLICE DEPARTMENT; REPEALING AND REPLACING CITY OF WARD RESOLUTION 2023-24

WHEREAS, the use of All-Terrain Vehicles is common place with many Police Departments for many uses to include but not limited to Special Events, searching for lost individuals and tracking fleeing suspects; and,

WHEREAS, THE CITY OF WARD POLICE DEPARTMENT has a need to replace their current All-Terrain "side-by-side" as their old one has been transferred to the Parks and Recreation Department for their use.

WHEREAS, IN OCTOBER 2023, RESOLUTION 2023-24 was approved to purchase a Side-by-Side from Sherwood Tractor; however, the company sold out of the model quoted between the time we received the quote and council approved the Resolution and a suitable substitute could not be located for the price approved by Resolution 2023-24; and,

WHEREAS, DOUG REYNOLDS SUZUKI has provided a quote (attached) and is holding the in-stock unit for our purchase.

NOW, THEREFORE, IT IS HEREBY RESOLVED THAT THE CITY COUNCIL OF THE CITY OF WARD:

SECTION 1: Authorizes the Mayor or City Clerk to purchase one (1) new CFMOTO All-Terrain "Side-by-Side" from Doug Reynolds Suzuki for a cost not to exceed \$20,474.43 per the attached quote and the need for additional quotes is waived.

SECTION 2: Authorizes this purchase to be paid from Police Department funds or General Funds and that the respective budgets are hereby amended, as needed.

SECTION 3: Resolution 2023-24 is repealed and replaced by this Resolution.
