- I. Call to Order: was called to order by Mayor Gastineau @ 10:30am

- II. Roll Call (COVID-19 Protocols): by City Clerk Ruble. Council Members Rummel present, Wier present, Harbort here, Hefner here, McMinn here, and Shetron here. We have a quorum

IV. Special Business:

- a. Introduction of Council Members, City Clerk and Mayor: Each council Member and City clerk introduced themselves to the community.
- b. Ordinance 2021-01: AN ORDIANANCE REPEALING AND REPLACING ORDINANCE O-2020-01, O-2020-05; O-2020-06; ESTABLISHING THE RULES AND PROCEDURES TO BE USED BY THE WARD CITY COUNCIL; DECLARING AN EMEGENCY; AND FOR OTHER PURPOSES: Mr. McMinn made a motion to put O-2021-01, second by Mr. Wier. Title Read by City Clerk. Mrs. Hefner made a motion to strike section 8, second by Mr. Harbort. Robin Commented that she feels that she was elected by the people and not the city and she does not work for the city. Mr. Harbort feels that it is his constitutional right to say what he wants to say on Facebook and feels it is his right. Mayor explained that this is simply an acknowledgment that you read the attachment. Judge McGue was asked to reflect to the council his interpretation of this action. Employee, Jamee B, spoke in favor of Council signing and acknowledging the policy that the employees are to sign and abide by. Citizen, Stacy M., spoke in support of signing and acknowledging our social media policy. She expressed how important it is that the city conducts themselves on social media professionally as this is how our city is perceived. Motion to strike section 8 failed with a 2-4 roll call vote. Rummel-nay, Wier-nay, Harbort-nay, Hefner-yea, McMinnnay, and Shetron-yea. Mr. McMinn makes a motion to suspend the rules and put O-2021-01 on its second and third reading, second by Mr. Rummel. Discussion. Motion

carries with a 4-2 roll call vote. Wier-yea, Harbort-yea, Hefner-nay, McMinn-yea, Shetron-nay, Rummel-yea. Mr. Wier makes a motion to adopt O-2021-01, second by Mr. Harbort. Discussion. Motion carries with a 4-2 roll call vote. Harbort-yea, Hefner-nay, McMinn-yea, Shetron-nay, Rummel-yea, Wier-yea. Mr. Harbort makes a motion to enact the emergency clause, second by Mr. McMinn. Discussion. Motion passes with 4-2 roll call vote. Hefner-nay, McMinn-yea, Shetron-nay, Rummel-yea, Wier-yea, Harbort-yea. Ordinance 2021-01 will become effective immediately. City Clerk Ruble asked the council members to sign the Conflict of Interest and Social Media packets and turn them back in to her.

c. State Holidays and Council Meeting Conflict: Mr. Wier Makes a motion to leave council meeting as is on January 18, 2021 and February 15, 2021, second by Mrs. Hefner. Motion carries with a 6-0 roll call vote. McMinn-yea, Shetron-yea, Rummel-yea, Wier-yea, Harbort-yea, Hefner-yea.
