Council Meeting Minutes July 18, 2022 at 6:30 PM

- <u>Call to Order:</u> Mayor Gastineau called the meeting to order at 6:30 P.M.
 - Prayer Art Brooke led the prayer
 - Pledge of Allegiance Mayor Gastineau led the pledge
 - Due to Mrs. Courtney Ruble resignation at the May 2022 council meeting; Mayor Gastineau requested that Deborah Staley record the minutes
- Roll Call: by Deborah Staley. Council Members Rummel present, Morris present, Harbort – present, Hefner – present, McMinn – absent, and Shetron – present. We had a quorum.
- Review/approval of June 20, 2022 Council Minutes

Council member Harbort made a motion to approve the June 20th, 2022 Council minutes; seconded by Council Member Hefner. No discussion. Motion passed with a 5-0 voice vote.

Department Reports and Financials:

- Animal Shelter, Court, Fire, Parks & Rec, Police, Probation, Reception, Street, Water/Wastewater – Council Member Rummel made a motion to approve the department reports; seconded by Council Member Morris. No discussion. Motion passed with a 5-0 voice vote.
- Financials
- General, Fire, Parks & Rec, Police, Street, Water/Wastewater Council Member Harbort made a motion to approve the department reports; seconded by Council Member Hefner. No discussion. Motion passed with a 5-0 voice vote.

• Planning Commission Report:

- Chairman Jerry Peters presented the Planning Commission report
- Grant and Julie Roberts have requested a variance to build a 4 foot fence in their front yard at 29 Shamsie. The Zoning Regulations only allow a 4 foot fence. The Planning Commission recommends approval by the Council. Council Member Rummel made a motion to approve the variance for a 4 foot fence at 29 Shamsie; seconded by Council Member Harbort. No discussion. Motion passed with a 5-0 voice vote.

- The Planning Commission approved the Preliminary Plat for Stagecoach Estate Subdivision
- The Planning Commission approved the Preliminary Plat for Deerfield Subdivision Phase VI. This is with the contingency that the section of the plat that is zoned C1 is successfully rezoned to R1 at the public hearing on July 25th at 6:30 PM.
- Steve and Nick Hester presented an 8-lot sketch plat on Moon Road. The Planning Commission approved the sketch plat with contingencies.
- Council Member Rummel made a motion to approve the Planning Commission report; seconded by Council Member Harbort. No discussion. Motion passed with a 5-0 voice vote.

Unfinished Business:

• ELECTION OF CITY CLERK (2ND ATTEMPT)

- Each Candidate was given 3 minutes to speak. Art Brooke spoke referencing
 his previous record as Mayor. Nicci Rummel spoke about how she would
 like to be more involved in the City of Ward. Also, referenced her
 availability.
- Council members were given a voting slip to complete. Council Member Rummel excused herself from voting. Attorney Chris Lacy gathered the voting slips and tabulate. The vote was 2 – Brooke and 2 – Rummel there was a tie.
- There was a second vote with the same result. (2-Brooke and 2-Rummel)
- Mayor Gastineau ask for guidance from Attorney Chris Lacy. The decision was made for Attorney Lacy to research and determine if the Mayor would be able to break the tie. Council Member Shetron motioned to table the election of a City Clerk and have a special council meeting on Monday, July 25th at 6:30 PM in the Mayor's office due to the Council chambers will be used for a rezone hearing at the same time; seconded by Council Member Harbort. Discussion. Motions passed with a 5-0 voice vote.

A. ANNEXATION ISSUE - SHAMSIE DR AND FARRAH DR

 Mayor Gastineau stated he has spoken to several different agencies and he and Attorney Gastineau are of the opinion this is a clerical error from the assessor office. The people in the effected area receive full city services and vote in all city elections. Attorney Lacy will continue to research this issue and return to the council with his recommendation.

VII New Business:

A. ZELLA'S TRASH FUEL SURCHARGE

- 15% Surcharge effective immediately
 - Surcharge in effect for 6 months when it will be revisited

- If Diesel prices drop to \$3.50 per gallon or below for a month, the surcharge will be dropped
- \$11.67 + 15% = \$13.42 (\$1.75 increase)
- Discussion
- Council Member Harbort motioned to accept the 15% Fuel Surcharge effective immediately for Zella's Trash Service to be revisited not later than January 2023; Council Member Morris seconded. Discussion. Motion passed with a 5-0 voice vote.

 - Deborah Staley read the title to the Ordinance.
 - Council Member Rummel motion to put the ordinance on the first reading for Ordinance No. 2022-09; Council Member Morris seconded.
 Discussion. Roll Call – Rummel – yes, Morris – yes, Harbort – no, Hefner – yes, Shetron – no. Roll call vote 3-2 motion passed.
 - Council Member Morris motioned to suspend the rules and put
 Ordinance No. 2022-09 on its 2nd and 3rd reading. Discussion. Roll call vote Morris yes, Harbort no, Hefner no, Shetron no, Rummel yes. Roll call vote 2 3 motion failed
 - This will be on the August regular monthly agenda for the second reading.

 seconded by Council Member Harbort. Roll call vote, Hefner yes,
 Shetron yes, Rummel yes, Morris yes, Harbort yes. Roll call vote
 5 0. Motion passed.
