

**CITY OF WARD
ORDINANCE O-2025-21**

AN ORDINANCE AMENDING ORDINANCE O-2025-05 ESTABLISHING PARKING RULES FOR THE CITY OF WARD, ARKANSAS CONCERNING VEHICLES EXCEEDING ONE-TON AND SEMI-TRAILER TYPE VEHICLES, ESTABLISHING PENALTIES, AND FOR OTHER PURPOSES

WHEREAS, ARKANSAS CODE ANNOTATED (A.C.A.) 24-49-106 provides that the City Council has the authority to regulate parking or vehicles on the streets and highways within the City; and,

WHEREAS, it is becoming more and more common place for large vehicles exceeding one-ton and semi-trailer type vehicles to be parked for extended periods of time in residential areas; and,

WHEREAS, parking of these types of vehicles creates a hazard to the residents and those commuting along with excessive wear-and-tear on city streets.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WARD, ARKANSAS THAT O-2025-05 SHALL BE AMENDED AS FOLLOWS

SECTION 1 – ADDITION

ADD: SECTION 5 – COMMERCIAL VEHICLE PARKING: It shall be unlawful for any person to park any commercial vehicle – exceeding one-ton - on any street in the city for any period of time except for loading and unloading. This includes semi-trailer type vehicles.

SECTION 2 – CHANGES TOP TO EACH SUBSEQUENT SECTION IN O-2025-05: Each Section is renumbered as shown.

- A. Section 6 – Temporary Parking Restrictions
- B. Section 7 – Builder Assurance, etc
- C. Section 8 – Enforcement
- D. Section 9 – Penalty
- E. Section 10 – Severability
- F. Section 11: Effective Date of Enforcement¹

¹ This applies to the Ordinance O-2025-05 only

SECTION 3 – SEVERABILITY: If, for any reason, any portion or portions of this ordinance shall be held invalid, such invalidity shall in no way affect the remaining portions.

SECTION 4 – CODIFICATION: This Ordinance shall be codified in the Ward Municipal Code and the sections may be renumbered or re-lettered to accomplish such intention

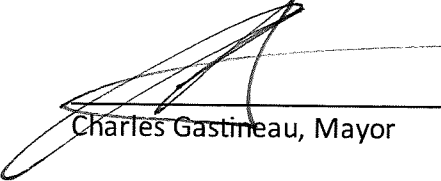

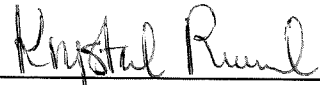
