**A RESOLUTION AUTHORIZING THE MAYOR AND/OR THE CITY CLERK OF THE CITY OF WARD TO ENTER INTO A CONTRACT TO PURCHASE ONE (1) 25-HORSEPOWER PUMP FOR WASTEWATER LIFT STATION**

WHEREAS, A.C.A. 14-235-203, states that “every municipality in the State of Arkansas is authorized and empowered to own, acquire, construct, equip, operate, and maintain, within or without the corporate limits of the city or town, a sewage collection system or a sewage treatment plant, intercepting sewers, outfall sewers, force mains, pumping stations, ejector stations, and all other appurtenances necessary or useful and convenient for the collection and treatment, purification, and disposal in a sanitary manner of the liquid and solid waste, sewage, night soil, and industrial waste of the municipality”; and,

WHEREAS, from time to time, it becomes necessary to replace pumps and other appurtenances to maintain an effective wastewater collection system; and,

WHEREAS, the City of Ward Wastewater System needs to purchase one (1) 25-horsepower pump to replace a pump that is non-repairable.


