A RESOLUTION AUTHORIZING THE MAYOR AND/OR THE CITY CLERK OF THE CITY OF WARD TO ENTER INTO A CONTRACT TO PURCHASE MULTIPLE WASTEWATER PUMPS

WHEREAS, A.C.A. 14-235-203, states that "every municipality in the State of Arkansas is authorized and empowered to own, acquire, construct, equip, operate, and maintain, within or without the corporate limits of the city or town, a sewage collection system or a sewage treatment plant, intercepting sewers, outfall sewers, force mains, pumping stations, ejector stations, and all other appurtenances necessary or useful and convenient for the collection and treatment, purification, and disposal in a sanitary manner of the liquid and solid waste, sewage, night soil, and industrial waste of the municipality"; and,

WHEREAS, from time to time, it becomes necessary to replace pumps and other appurtenances to maintain an effective wastewater collection system; and,

WHEREAS, the City of Ward Water/Wastewater System desires to purchase 12 pumps as noted on the attached quote. Doing so will ensure two pumps are in every lift station and a replacement pump is in stock should a larger pump at Moon, Morrison, or Industrial fail. The attached proposal also allows for one additional "razor" pump being furnished at no additional charge which will be held in stock to be used, as needed.

NOW, THEREFORE, IT IS RESOLVED THAT THE CITY COUNCIL OF THE CITY OF WARD hereby declares that the Mayor and/or the City Clerk may enter into a contract with J.R. Stewart Pump and Equipment to purchase the pumps listed on the attachment. Further, a bid by said Contractor is hereby accepted in the amount of \$73,110.14 including tax and shipping. Per A.C.A. § 14-58-303(b)(2)(B), Council hereby waives the bidding process in this matter as it would not be feasible or practical.
