A RESOLUTION AUTHORIZING THE MAYOR OR CITY CLERK TO ENTER INTO A CONTRACT WITH WHITE RIVER CONSTRUCTION TO COMPLETE ACEDP GRANT #790-09046; AND TO APPROPRIATE ADDITIONAL FUNDS

WHEREAS, IN JUNE 2019, THE ARKANSAS ECONOMIC DEVELOPMENT COMMISSION (AEDC) awarded the City of Ward a \$200,000.00 grant to rehab a portion of the city's wastewater system and remove 17 houses off the vacuum portion; and,

WHEREAS, THE CITY OF WARD received several bids for said project which was estimated to cost \$227,710.00; and,

WHEREAS, BOND CONSULTING ENGINEERS certified White River Construction of Bald Knob AR as the low bidder with a bid of \$244,015.00 (attached); and,

WHEREAS, because the bid is higher than the estimated amount, additional funds must be appropriated to complete the project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF WARD, ARKANSAS, HEREBY;

SECTION 1: Declares that White River Construction is hereby awarded the contract to complete the project and authorizes the Mayor or City Clerk to sign any and all documents to execute same.


SECTION 2: Authorizes and appropriates an additional funds not to exceed \$50,000.00 to complete the project.


