A RESOLUTION AUTHORIZING THE MAYOR OR CITY CLERK TO ENTER INTO A CONTRACT WITH BOND CONSULTING ENGINEERS FOR THE PURPOSE OF ENGINEERING THE BALDING STREET IMPROVEMENT

WHEREAS THE CITY OF WARD is constantly seeking ways to improve existing infrastructure as we as setting standards for new projects; and,

WHEREAS BALDING STREET, purportedly being one of the first streets paved in the City of Ward is in need repair and widening to current standards; and,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF WARD, ARKANSAS, HEREBY;

SECTION 1: The Mayor or City Clerk is hereby authorized to enter into a contract with Bond Consulting Engineering as outlined below and per the attached proposal.

- Engineering Design Fee: \$20,500
- Administration Fee: \$11,900
- Construction Layout and Staking Fee: \$8,600

SECTION 2: Authorizes and appropriates additional funds not to exceed \$47,150 (\$41,000 + 15%). General funds will be used and transferred to the Street Department fund, as needed.

SECTION 3: Actual construction of the project will be dependent on availability of federal/state/local funds to finance the project.

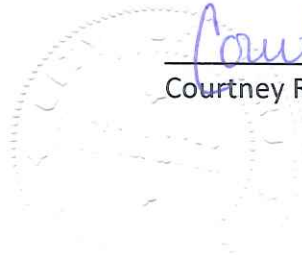

Engineering Design Fee \$ 20,500

Construction Layout and Staking Fee \$ 8,600

- This price includes the following items: layout street and storm drainage infrastructure for construction to meet plans and specifications.
