**A RESOLUTION ACCEPTING MOYER EXCAVATING & TRUCKING AS THE LOW BIDDER FOR THE DEMOLITION OF CITY OWNED PROPERTY AND AUTHORIZING THE MAYOR AND/OR CITY CLERK TO SIGN APPROPRIATE DOCUMENTS FOR THE PROJECT**

**WHEREAS, THE GOVERNING BODY OF THE CITY OF WARD** authorized the demolition of the following city-owned properties with the City of Ward; and,

- 404 2<sup>nd</sup> St
- 100 Owen St

**WHEREAS** the City properly published a Request for Proposal (bid request) and received five (5) bids as noted below for the demolition and removal of said properties. Each bid was opened and read on August 8, 2024 beginning at 2:00 pm.

**WHEREAS**, all bids listed below were received in a timely manner and evaluated by the Mayor, Public Works Superintendent, and the HR-Finance Director.

- b. The use of City of Ward Water/Wastewater Funds for the 404 2<sup>nd</sup> St property is hereby approved and appropriated.
- c. Each respective budget is hereby amended thereto.

SAID RESOLUTION WAS ADOPTED ON 8-20-24.


