A RESOLUTION ACCEPTING CK ASPHALT AS THE LOW BIDDER TO OVERLAY CAMPBELL ST, CROSS ST, AND MILAM ST; AUTHORIZING AND APPROPRIATING FUNDS; AND AUTHORIZING THE MAYOR AND/OR CITY CLERK TO SIGN APPROPRIATE DOCUMENTS FOR THE PROJECT

WHEREAS, IN APRIL 2025 THE GOVERNING BODY OF THE CITY OF WARD authorized the Mayor to enter into a contract with Bond Engineering for the purpose of engineering a project to overlay Campbell, Cross and Milam Streets; and,

WHEREAS IN JUNE 2025, BOND CONSULTING ENGINEERS properly published a Request for Proposal (bid request) and received two proposals which were opened and read on July 1, 2025; and,

WHEREAS, BOND CONSULTING ENGINEERS certified CK Asphalt as the low bidder for the project with a bid (attached).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF WARD, ARKANSAS, HEREBY DECLARES;

SECTION 1 – AWARD: That CK Asphalt be awarded the contract to overlay Campbell, Cross and Milam Streets for an amount not to exceed \$91,428.00 – except as noted in Section 3 – and authorizes the Mayor and/or City Clerk to sign any and all documents to execute same.

SECTION 2 – FUNDING SOURCE: The use of Street Department Funds is hereby approved and appropriated to complete the project and the respective budget amended thereto.

SECTION 3 – EXCESS FUNDING: That additional funds not to exceed 10% of the bid amount if needed for unforeseen cost overruns are hereby authorized and appropriated.
