RESOLUTION No. R-2025-41**

A RESOLUTION AUTHORIZING THE MAYOR AND/OR THE CITY CLERK OF THE CITY OF WARD TO ENTER INTO A CONTRACT TO PURCHASE ONE (1) 2026 DODGE DURANGO VEHICLE FROM RED RIVER DODGE IN HEBER SPRINGS, ARKANSAS FOR THE FIRE DEPARTMENT

WHEREAS, maintaining city equipment is a priority, it becomes necessary from time-to-time to replace worn out equipment that has become more and more expensive to maintain; and,

WHEREAS, THE CITY OF WARD FIRE DEPARTMENT desires to purchase one (1) new 2026 Dodge Durango to replace the 2015 Dodge Ram 1500¹ currently being used by the Fire Chief.

WHEREAS, DURING THE SEPTEMBER 2025 CITY COUNCIL MEETING, THE GOVERNING BODY approved, by Motion, to purchase a new vehicle for the Fire Chief utilizing the state contract.

NOW, THEREFORE, IT IS RESOLVED THAT THE CITY COUNCIL OF THE CITY OF WARD HEREBY DECLARES THAT:

SECTION 1 – AUTHORIZATION: The Mayor and/or City Clerk is hereby authorized to enter into a contract with Red River Dodge in Heber Springs, AR to purchase one (1) 2026 Dodge Durango AWD vehicle for a price not to exceed \$40,750² as shown on the attached with options.

SECTION 2: BIDS: The need to solicit bids is not required per Arkansas Code Annotated (A.C.A.) 14-22-106.

SECTION 3: ADDITIONAL COSTS:

a. An additional \$20,000.00³ to fully equip the unit is authorized and appropriated.

b. Sales tax, if applicable, on the purchase of the vehicle is also authorized and appropriated.

SECTION 4 – FUNDING: The use of Ward Fire Department Operational and/or Reserve Funds is hereby authorized and the respective budgets amended thereto.

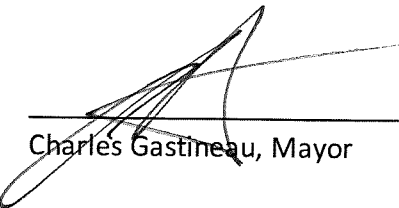

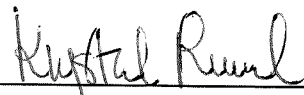

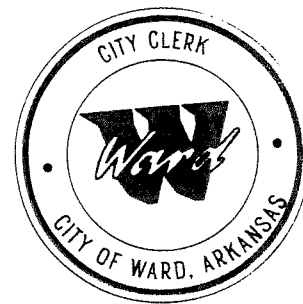
