**A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH  
BOND ENGINEERING TO DESIGN AND MANAGE  
A PROJECT TO OVERLAY/IMPROVE SEVERAL STREETS AND THE CITY HALL PARKING LOT**

**WHEREAS**, improving city streets is a continuing process and while some streets can be overlaid using Street Aid funding, others like dead ends cannot; and,

**WHEREAS**, during the September 2025 City Council meeting, Council agreed, by Motion, to overlay several streets listed below and the City Hall Front Parking lot.

- Stephens St (Dead End)
- Spencer St<sup>1</sup>
- Kirkland St (Dead End)
- Hilburn St (Dead End)
- Grant St (Dead End)
- Circle B. Dr (Dead End)
- Marshal St from Grissom (Dead End)<sup>2</sup>

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF WARD, ARKANSAS**, that the Mayor and/or City Clerk is authorized to enter into an agreement (attached) with Bond Engineering to prepare an overlay plan and manage the bidding process along with construction management.
